# **Continuing Education Initiative:**

Chris Wasmer reported that we have to determine what each state requires for CEU approval; via research she has determined that NCIDQ and IDEC are the standard for many states. Analyzing state requirements is a big undertaking for determining licensing requirements/boards etc. NEWH is looked upon as a "provider"; very political aspects; labor laws become an issue to research.
