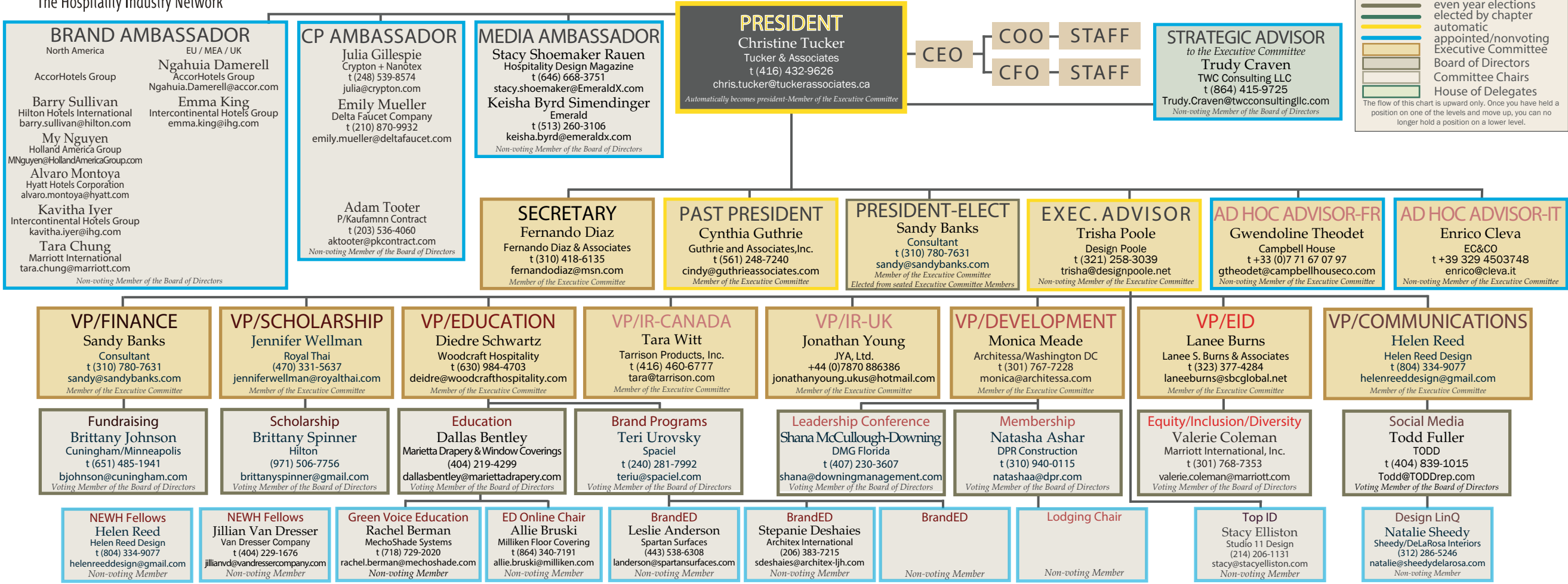


## 2023 Board of Directors Organizational Chart
